All items must be hand-made or produced by the enterprise/person applying or his/her employees. Prints of original works of art are allowed, but no mass-produced items.

To protect all Vendors, items that are not listed above will not be allowed to be sold.

Vendors who do not abide by the terms and conditions will be removed from the grounds.

Arts and Crafts Vendors will be limited to no more than twelve (12) so those selected have a fair opportunity to make a profit.

No electricity will be provided to Vendors by the festival producers. No generators will be allowed. Vendors should be prepared to set up and sell without electricity or use battery-powered sources for electricity.

Arts and Crafts Vendors are required by the City of New Orleans to have an occupational license or temporary permit, (OAMSC is required to submit a list of vendors to the Office Safety and Permits. Note that Vendor will be liable for sales tax payments to the City of New Orleans.)

**LOAD IN/LOAD OUT:**

Arts and Crafts Vendors will be required to be on grounds no later than 10:30 A.M. the day of the event and set up and ready to sell by 10:45 A.M. Vendors will not be allowed to leave the event until 4 P.M. unless inclement weather or other danger occurs during the event.

Vendors must check in with staff/volunteers upon arrival. Vendors will unload and set up on a first-come, first-served basis. Parking space will be available on the street or nearby.

By signing this application, you agree to hold harmless Old Algiers Main Street Corporation, the City of New Orleans and State of Louisiana. Any damage or injury incurred by Vendor, its employees or patrons will be the sole responsibility of the Vendor.
